### **NOTICE OF ELECTIONS/CALL FOR NOMINATIONS - 2018 NYSLC ELECTIONS**

Pursuant to Article X, Section 1.i. of the UUP Constitution, this is the notice of election and call for nominations for: (1) the Officer Positions of NYSLC President, 1<sup>ST</sup> Vice President, Vice President for the Western Region, Secretary, Treasurer; (2) NYSLC Representative Assembly Delegates from the designated regions; and (3) Delegates to the NYSUT Representative Assembly and Other Affiliate Conventions. By reason of the office, all Officers are also members of the NYSLC Representative Assembly. Also, by reason of their offices, the President and the Vice President shall serve as Delegates to the NYSUT Representative Assembly and Other Affiliate Conventions, and the Vice President for the Western Region will be an Alternate Delegate to the NYSUT RA and Other Affiliate Conventions. The nominating forms for all elections are enclosed.

1. Individuals who wish to run for any position must nominate themselves. These individuals must be members of NYSLC as of the certification date for this election.
2. Individuals who wish to run for Delegate to the NYSLC Representative Assembly must self-nominate and be members of NYSLC **FROM THEIR REGIONS AND PARKS** as specified on the nomination form.
3. Mail your completed nominating form(s) to UUP Constitution and Governance Committee, P.O. Box 15143, Albany, NY 12212-5143, in time to be received before 5:00 p.m. on **Wednesday, July 25, 2018**. Nominations will close at that time. Any nomination received after that time will not be accepted. Nominations must be received **BY MAIL** and must be **RECEIVED**, not postmarked, no later than 5:00 p.m. in the UUP Administrative Office on **Wednesday, July 25, 2018**. UUP is not responsible for any delays by the United States Postal Service (USPS) or any private delivery company. Please allow seven to ten days mailing time.
4. Nominees may submit written statements of up to 500 words in support of their candidacies to [Nyslifeguardcorps@gmail.com](mailto:Nyslifeguardcorps@gmail.com) by 5:00 p.m. on Wednesday, **July 25, 2018**, for distribution to the membership by NYSLC. Statements will be unedited, and only the first 500 words of longer statements will be used.
5. To be eligible to participate in this election, individuals must be NYSLC members in good standing as of the certification date for this election, July 2, 2018.
6. For each Officer position, the individual receiving the highest number of votes will be elected. Ties will be determined by lottery.
7. For Delegates to the Representative Assembly, the individual receiving the highest number of votes in each region will be elected. All others receiving votes will be elected alternates for their respective regions in order of votes received. Rank order of those tied will be determined by lottery.
