A decision to seek election as the statewide chairperson for the UUP Committee on Active Retired Membership (COARM) is not an easy one. Following the superb leadership of Judy Wishnia is a daunting task. She has set the bar extraordinarily high with her years of dedicated commitment to preserving and protecting our earned benefits, higher education union goals and pertinent articles for the award-winning *Active Retiree* publication.

As a role model, I have tried, over the years, to emulate Judy's example of union leadership, but in my own way and style.

When UUP was founded, I was there. I have served without prejudice under the presidencies of Nuala Drescher, Tim Reilly, Bill Scheuerman, Fred Floss, Phil Smith and Fred Kowal—for the good of all our members. I have walked picket lines, attended and written articles as a professional and delegate to the DA, the RA and AFT assemblies for over 30 years; as the chapter Vice President for Professionals; as a member of the statewide Executive Board; as chapter president for three terms; and as UUP's membership development officer for four terms; and now as the elected Southern Tier retiree representative for six years;

and as a rep to the Alliance for Retired Americans; and serving on the newly accredited UUP/NYSUT Retiree Council 40-42.

Of all the accomplishments, large and small, during this "lifetime" of union service, I am most proud of creating, with Nuala Drescher and Mary Edwards, the UUP Committee on Womens' Issues and, as the MDO, the award categories for the Mitchell yearly awards and Retiree of the Year honoring our union activists.

As the MDO, I was committed to assisting chapters develop membership involvement by creating calendars of timed activities and means of union service, enabling our members to participate more fully in the activities of UUP.

I have also worked as the regional rep to help create distribution lists to enable COARM to be in touch with our members on a regular basis, to have campus/area meetings in the region to enable more members to attend COARM meetings. Additionally, I have been a strong promoter of regional or local advocacy being sensitive to the difficulty of our members to get to Albany, especially in the winter. Recently, I served with Barbara Maertz on the COARM sub-committee to preserve and protect our insurance and travel benefits.



Needless to say, there is much more to be done by COARM to involve the retirees in support of UUP activities. Not only would it be ideal for the retirees to be committed to the fight to preserve and protect our earned benefits against those who would diminish them, but to work to make sure they are there for future UUP retirees.

I would work to involve those UUP retirees who live out of state, whether year round or winter escapees, to organize as a force in their adopted retirement communities from Arizona to Florida. Many retirees have found second careers, volunteer countless hours in community work and put their years of learning and experience to good purposes. These good deeds need to be recognized as good publicity for UUP.

More importantly, I would continue working with the active membership, indeed continue teaching them, that retirees have much to offer their "active" colleagues. We represent the living history of unionism, UUP in particular, which must not be forgotten. I often find myself at chapter meetings reminding my younger colleagues that we have "been there and done that."

Let's use the knowledge of our retirees and together, let's move the union on!

In the upcoming election, I am seeking to be elected as the Retiree Delegate and Chair of the Committee on Active Retired Membership (COARM). COARM represents the nearly 5,000 UUP retirees and is the single voice for retirees on the UUP Executive Board.

Additionally, the Retiree Delegate must be a link to the active members in UUP and our affiliates, NYSUT, AFT and NEA, as well as to our retiree-specific affiliates, ARA and the Senior Action Network. The delegate routinely informs members of activities and helps coordinate the publications of an award-winning newsletter—the only vehicle that we know reaches every member.

I have served UUP and SUNY with energy and enthusiasm since I joined the faculty at SUNY Plattsburgh in 1977 as an associate librarian. I retired as a librarian and associate in women's studies in 2011. I have been grateful every day for the quality of my life and health. I thank the union for those benefits. I have had extraordinary opportunities and colleagues and I want to continue the work of representing and working with one of our most important populations—retirees



who have interests, passion and strong voices for justice and fairness.

We must encourage more retirees to be active in improving and preserving the benefits we worked for. I will keep you informed of relevant state and federal issues of concerns to retirees. I am committed to encouraging UUP retirees to play an active role in these matters.

We need to improve methods of communications with our colleagues, no matter where they have "landed" for retirement. While most of our retirees are predictably centered in New York, we have a significant percentage who now live out of state, but who retain their interest in SUNY, public higher education and, particularly, in Social Security, Medicare and the implications of the Affordable Care Act.

If elected, I will encourage COARM members to become more connected and active in UUP retiree issues. I'd like to be sure that we are giving as many people as much notice, encouragement and support to maximize our "imprint." To do this, I want to see better coordination for UUP retirees to attend meetings, fund-raisers and regional meetings of our affiliates, including the SUNY Retirees Council, the NYSUT regional retirees events, and area events involving labor, religious and service coalitions that bear on our interests. Better coordination of these activities can only result in better representation.

I believe I have the interest, personality and experience to do it—as long as I have your help and advice. I want to hear from you. I'd like your support and your vote.

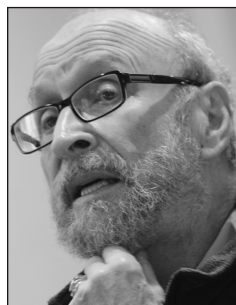


Statements for Regional Members of COARM

Representing the Long Island Region for the last six years has been a rewarding and interesting venture. I have come to know many of you at the local brunch meetings that we have in spring and fall. Through these events, much information has been given to retirees about dental, vision and UNUM benefits and the status of Social Security, Medicare and government initiatives like IRMAA legislation.
