## **Statements for Regional Members of COARM**

#### Al Magid: Capital District—Region A

I have served several terms as regional chair of the Capital District Region of COARM. My experiences have provided me great satisfaction relating to my sense of having been effective.

As Capital District chair, I've worked with an executive committee adept at mounting imaginative and stimulating forum/brunches each October and May, those events held at Alumni House on UAlbany's main campus and centered on guest speakers addressing important issues mostly of public policy in the political, economic and educational spheres, domestic and international. I want to be available to help shape those events. Attendees have come from the Albany, New Paltz and Cobleskill campuses and from SUNY System Administration, providing an opportunity for retired SUNY academics and professionals to meet and exchange. The proceedings have been enriched also by the participation of UUP staff members Walt Apple and Rob Trimarchi, as presenters of important and timely information about SUNY retiree benefits and other matters.

I am a contributor of articles to The Active Retiree, the



statewide COARM newsletter, and to a SUNY System Administration organ, the *SUNY Retirees Newsletter*, and a member of the latter publication's editorial committee.

As a regional representative on the statewide COARM, I continue to engage retiree issues and concerns that have state and even national resonances, affording me many opportunities to see, think about and

act upon matters of both narrow focus and broad sweep. Apropos, I am a co-plaintiff in a lawsuit filed by NYSUT and other public sector unions against the State of New York, which lawsuit challenges changes made to the New York State Health Insurance Program (NYSHIP) by Gov.r Andrew Cuomo in 2011, to the percentages of premiums that retirees must pay for their health coverage. The lawsuit is progressing through the state courts.

Collectively, these interests in SUNY retiree affairs motivate me to seek re-election as chair of the Capital District Region of COARM. I welcome the support of those who think I should continue in that office.

#### Charles McAteer: Long Island Region—B

My name is Charlie McAteer and I am running for the COARM's Long Island Representative. I worked at Stony Brook University for 37 years prior to retiring as a professional in the Campus Planning, Design & Construction group in 2015. I have lived on Long Island my whole life, and am a proud product of the SUNY system in both my undergrad, graduate work and professional training.

I have held several chapter officerships (treasurer and vice president for professionals) and UUP statewide committee assignments (Outreach/RELAG, Finance and Task Force for Retiree Issues). I have had the honor of receiving statewide awards for Advocacy & Organizing from two organizations (UUP 2016 Judy Wishnia Advocacy Award from Outreach Committee and the AARP-NY 2016 Organizer of the Year for their Statewide Legislative Advocacy Group).

This brief biography shows I am committed to working and excelling in the work I do for my organizations and here is what I plan on doing for *you* on Long Island as a retired member of our UUP union. I want to work with the newly created chapter Officer for Retirees from the four Long Island chapters (Stony Brook HSC, Stony Brook, Farmingdale and Old Westbury), as well as Empire State College Chapter members who worked on



Long Island when they retired. I was the author of the UUP constitutional amendment to create this missing link in our COARM structure—that being a contact person in each UUP chapter, the new Officer for Retirees. As your COARM representative statewide representing Long Island, these Officers for Retirees will be the link working with myself, your chapter

and COARM to better serve your needs and assist in organizing our very popular UUP Long Island retiree luncheons. I look to continue the tradition of having these fall and spring get-togethers in both Nassau and Suffolk counties.

I ask for your support for my candidacy for the Committee on Active Retired Membership's Long Island Representative position, so that I can continue the great work of Barbara Maertz, who has served in this position for the last 10 years.
